Dear Administrator/Provider:

The Department of Social and Health Services (Department) is providing guidance for when a Character, Competency, and Suitability (CCS) Assessment is required following a Background Inquiry and/or a Fingerprint Check.

When a new staff is hired for employment by a Long-term Care (LTC) provider, a Washington State Name and Date of Birth (WNDOB) Background Inquiry (BGI) is required. Once completed, the provider may hire provisionally while a Nationwide Fingerprint (FP) Check is being completed provided that:

- The BGI does not reflect any criminal convictions or pending charges that would be disqualifying per <u>Chapter 388-113 WAC</u>; or
- The BGI reflects no record; or
- The BGI reflects criminal convictions or pending charges that are not considered disqualifying per <u>Chapter 388-113 WAC</u>; and
  - The provider completes a CCS Review to determine if access to minors or vulnerable adults is appropriate.

This Dear Provider Letter is intended to clarify that, when a BGI reflects criminal convictions or pending charges that are not considered disqualifying, a provider may hire an employee on a provisional basis for up to 120 days pending a FP Check. However, a CCS review must be completed prior to working unsupervised with minors or vulnerable adults.

Once the FP check results are received, an additional CCS review is required only when the FP results indicate additional, non-disqualifying criminal convictions or pending charges that were not reflected in the BGI.
