# Traumatic Brain Injury in Corrections PILOT PROJECT July 2020 - June 2024

In July 2020 the TBI Council started a pilot project to improve the lives of people with Traumatic Brain Injuries in correctional facilities.

#### THE TBI IN CORRECTIONS PILOT PROJECT PROVIDED:

- TBI screening
- Incarcerated resources
- Support groups
- Training and skill building
- Workforce training
- Resource development

#### SMALL INVESTMENT. BIG IMPACT.

## An investment of 9¢ per day (\$32/yr) for each incarcerated person\* would:

- reduce recidivism, at an average cost of \$41K/yr
- reduce risk of injury for corrections system employees
- provide TBI learning opportunities, mental health support, skill building, resource connections and re-entry into the community

\*Cost based on 12,406 total incarcerated individuals in WA Corrections systems (as of Feb 2023) and a total annual cost of \$400,000.

### The program was offered at five locations:

- Airway Heights Correctional Center
- Coyote Ridge Correctional Center
- Monroe Correctional Complex
- Stafford Creek Correctional Center
- Washington State Penitentiary

**Health Equity & Belonging:** While anyone can experience a TBI, data shows that certain populations are more likely to die from a TBI or experience long-term health effects, including people in correctional facilities.



Despite its popularity and importance, this program ended in June 2024 due to a lack of funding for a permanent program. \$400K/yr would expand the program statewide and help more than 9,000 people with TBI.
