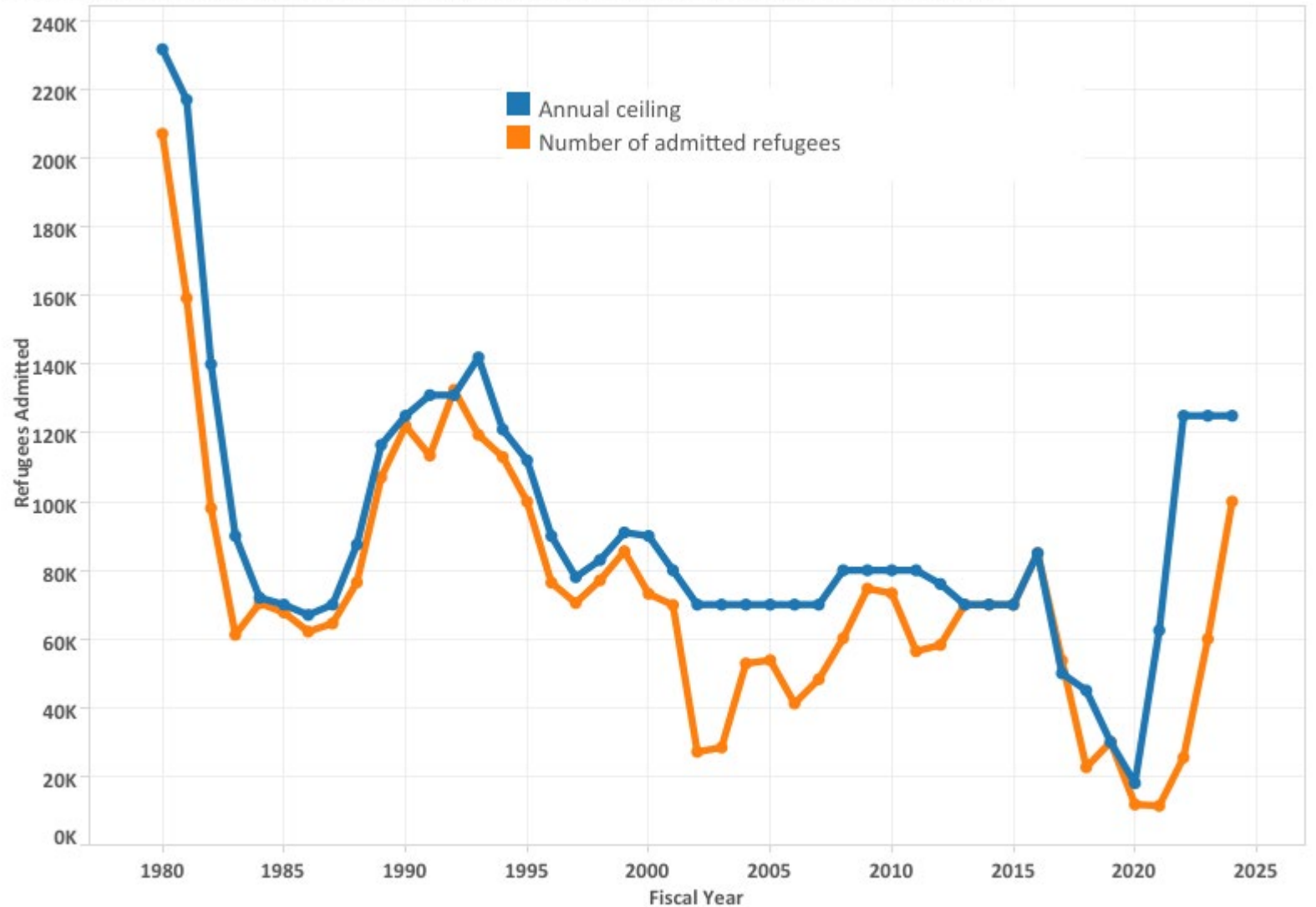

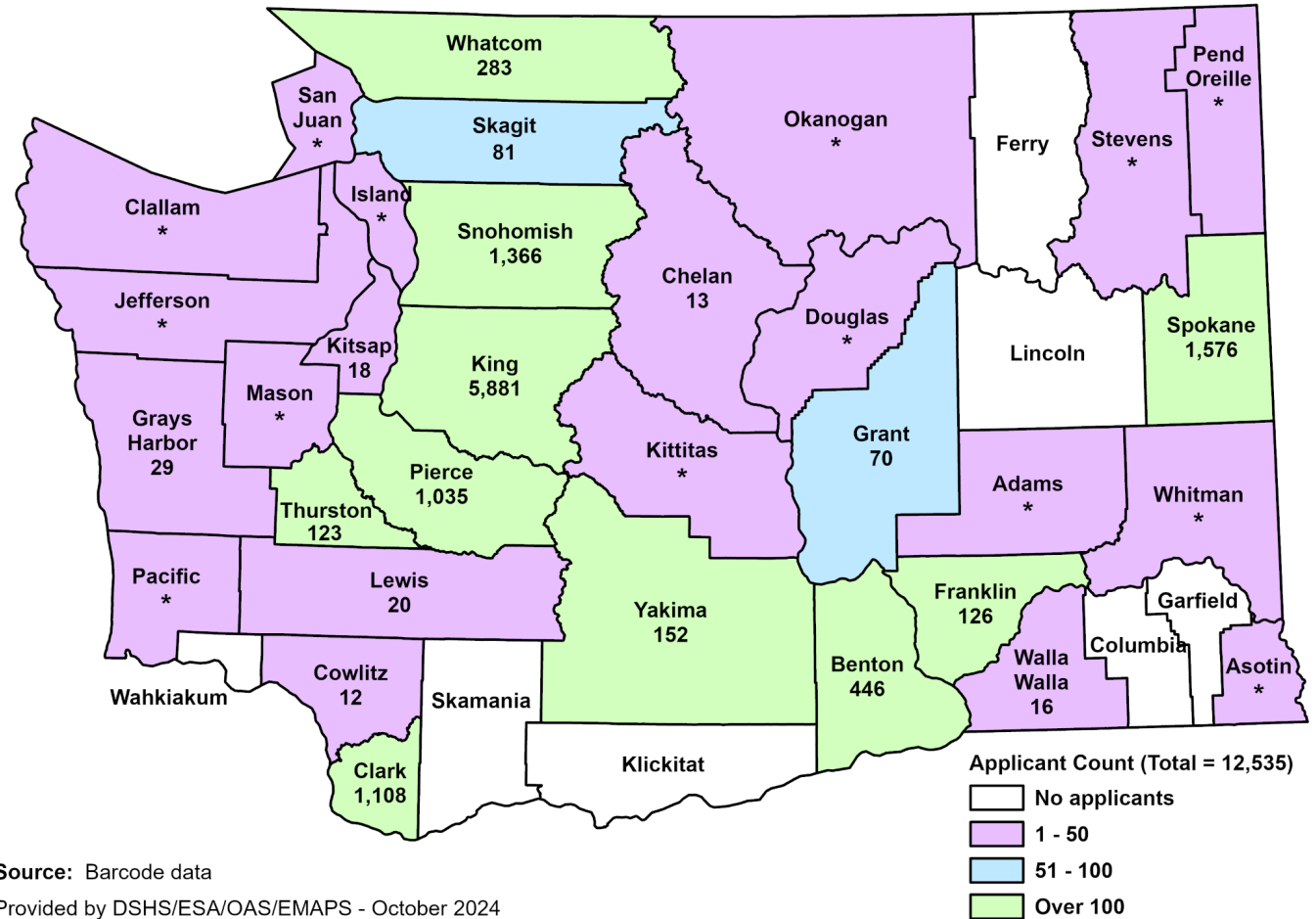

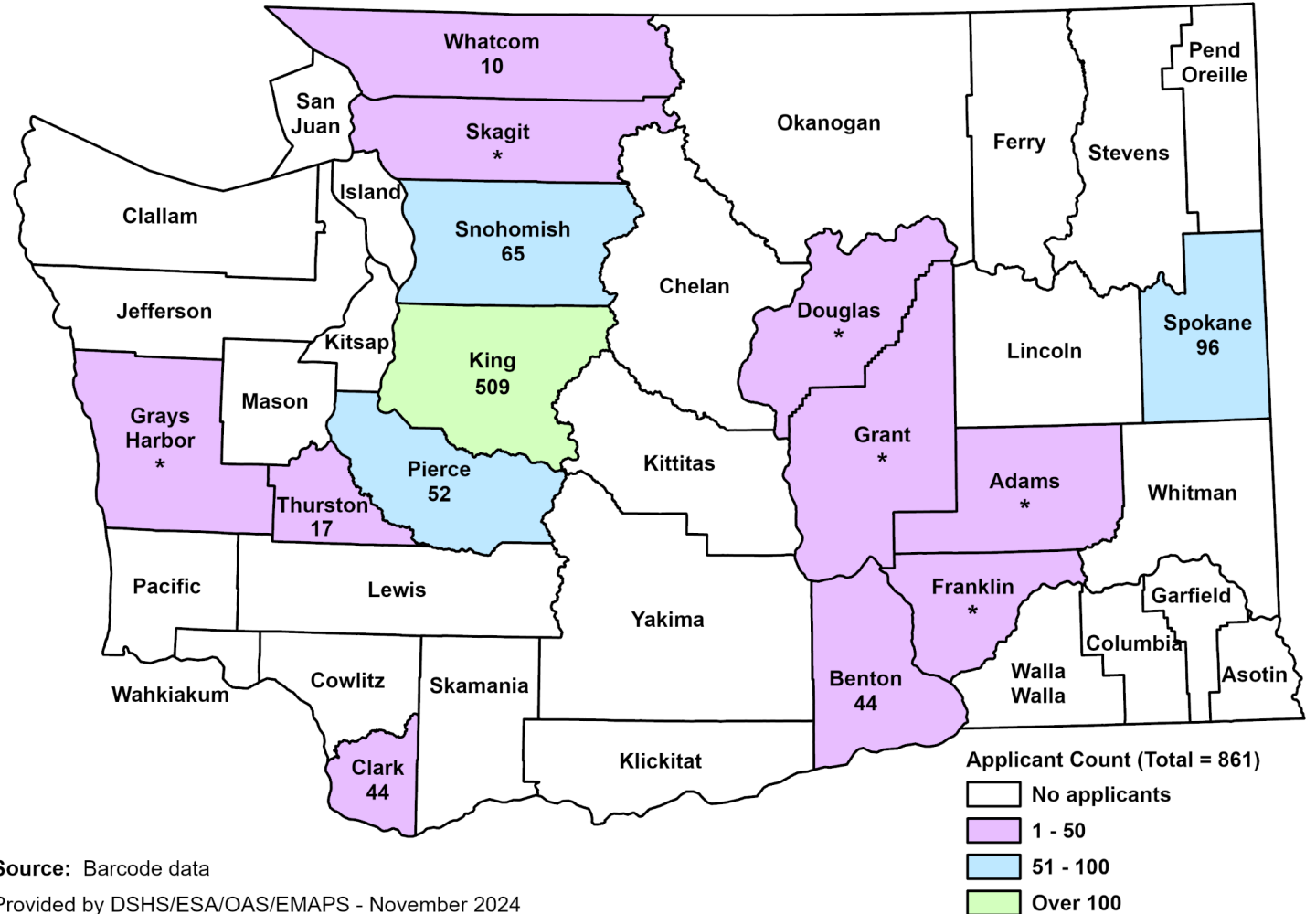

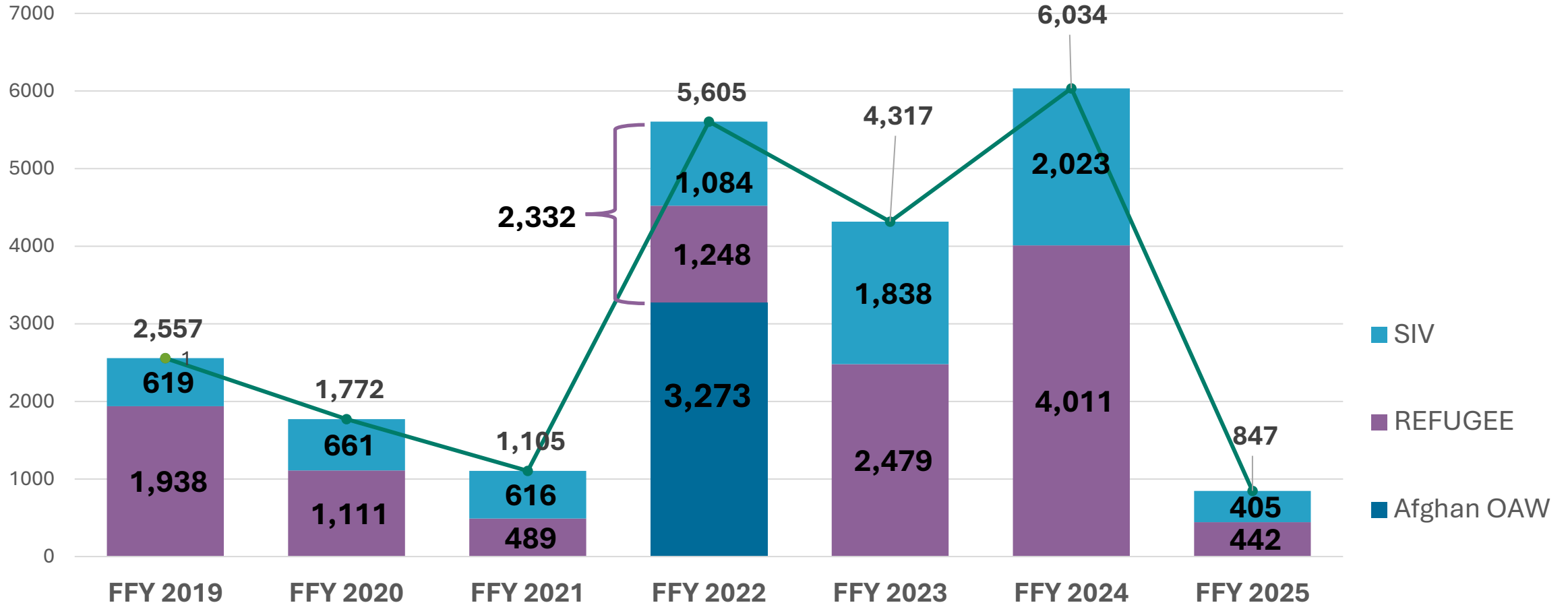

Your situation is unique. Contact us if you have questions. We provide support in more than 200 languages. You can ask for an interpreter by phone, find an assister by language or request translated materials. These services are free to you.

Did you know?

- 1 You do not need a social security number to apply.** People with many different statuses can get covered through *Washington Healthplanfinder*.
- 2 Laws protect you and your family.** By law, your information can only be used to find a health plan for you.
- 3 You could get free or low-cost coverage.** Many people can get *Washington Apple Health (Medicaid)* for little to no cost.

Applying is free and confidential

You can apply for a health plan online, over the phone or on our app. To get started, create an account on wahealthplanfinder.org, call 1-855-923-4633 or download the *WAPlanfinder* app.

Get support where you live. Brokers and navigators around the state provide support with getting coverage. They can answer your questions and help you get enrolled. Visit wahealthplanfinder.org or call 1-855-923-4633 to search for one by language.

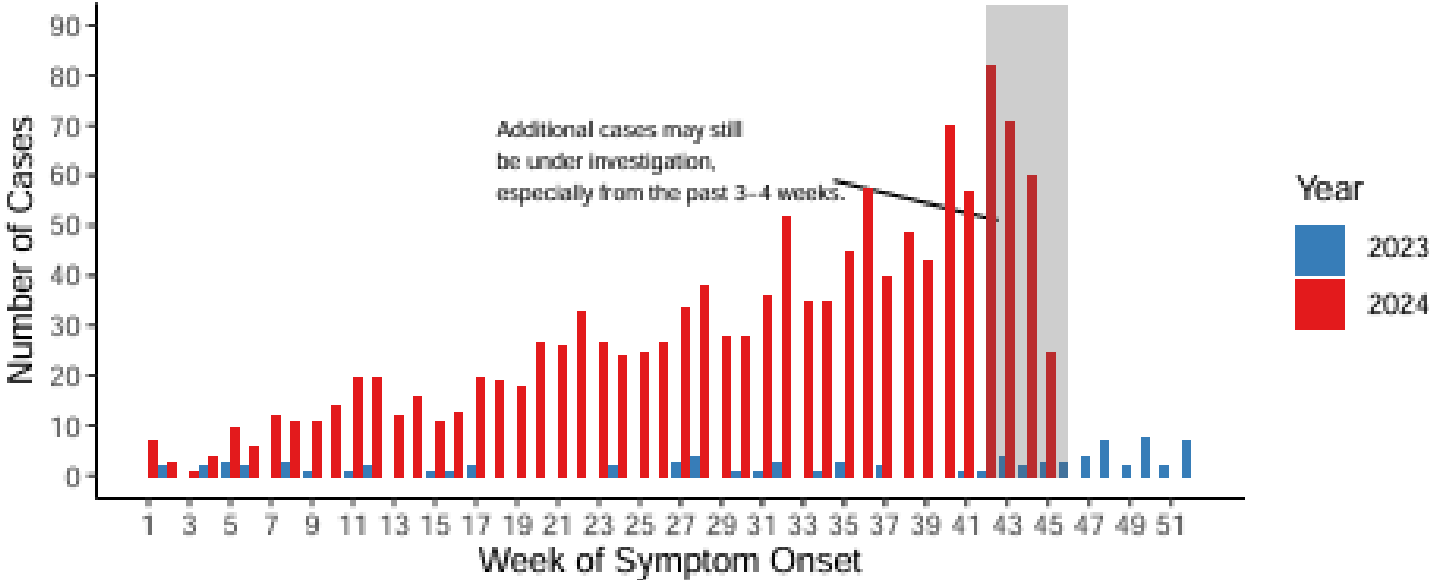
Washington state sees steep increase in whooping cough cases

Number of Pertussis Cases Reported in Washington State

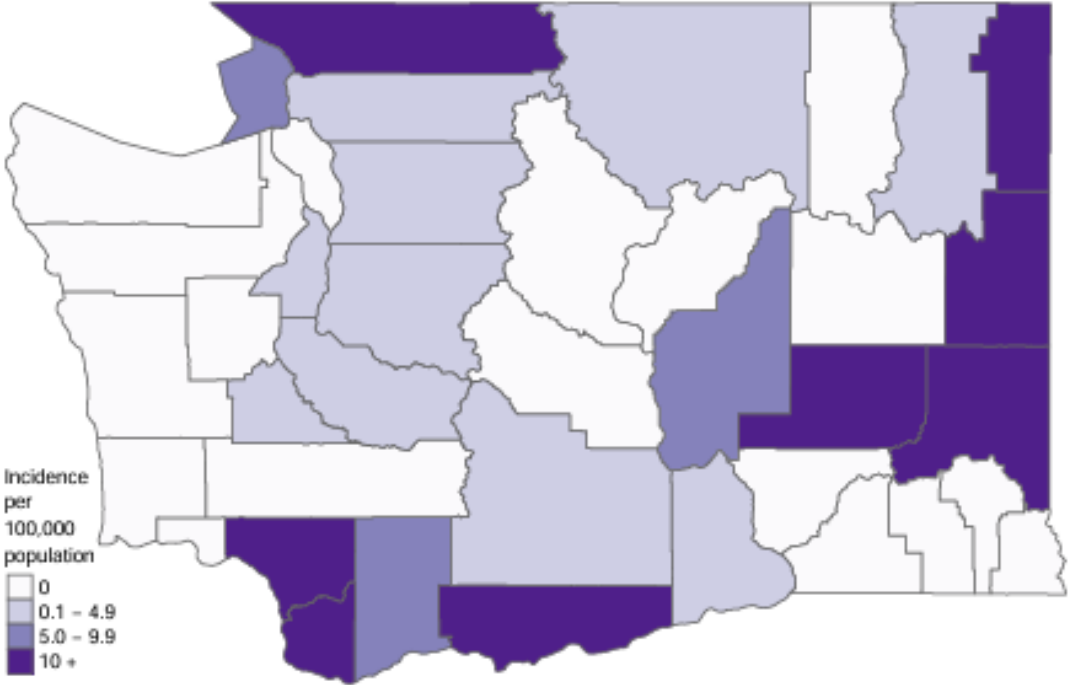
Figure 1: Number of Pertussis Cases Reported in Washington State by CDC Week of Symptom Onset: 2023 (blue) vs 2024 (red)

What is whooping cough?

Whooping cough, also known as pertussis, is caused by bacteria that spreads from person to person in the air. Some signs are:



coughing
fits



vomiting



difficulty
breathing

Who can get very sick?

Babies can get very sick from whooping cough. While some babies do cough, many babies don't cough at all. Instead, they may struggle to breathe.

Whooping cough can lead to hospitalization, pneumonia, brain damage, or even death.



What can I do to protect myself and others?

People of all ages can get vaccinated to protect themselves and others.

How does vaccination protect babies during pregnancy?



When you get vaccinated, your body makes antibodies that get passed along to your baby. The antibodies protect your baby during the first few months of life.

If you are pregnant, get vaccinated early in the third trimester of your pregnancy. If you are sick with a cough, don't visit babies or pregnant people.

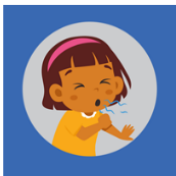

Definitions

Refugee: an individual that has fled their home country and cannot return because they have a well-founded fear of persecution due to their race, religion, national origin, membership in a social group, or political opinion. Refugees apply for and are granted a stable immigration status by the Department of Homeland Security and are admitted into the United States under that status.

Humanitarian Immigrants (federally-eligible)

- Asylee or someone granted asylum by the U.S. government.
- Certified Victim of Human Trafficking.
- Amerasian.
- Cuban-Haitian Entrant.
- Afghan and Iraqi Special Immigrant Visa holders (SIVs).
- Certain Afghan and Ukrainian humanitarian parolees

These individuals do not qualify for WA MASS services.

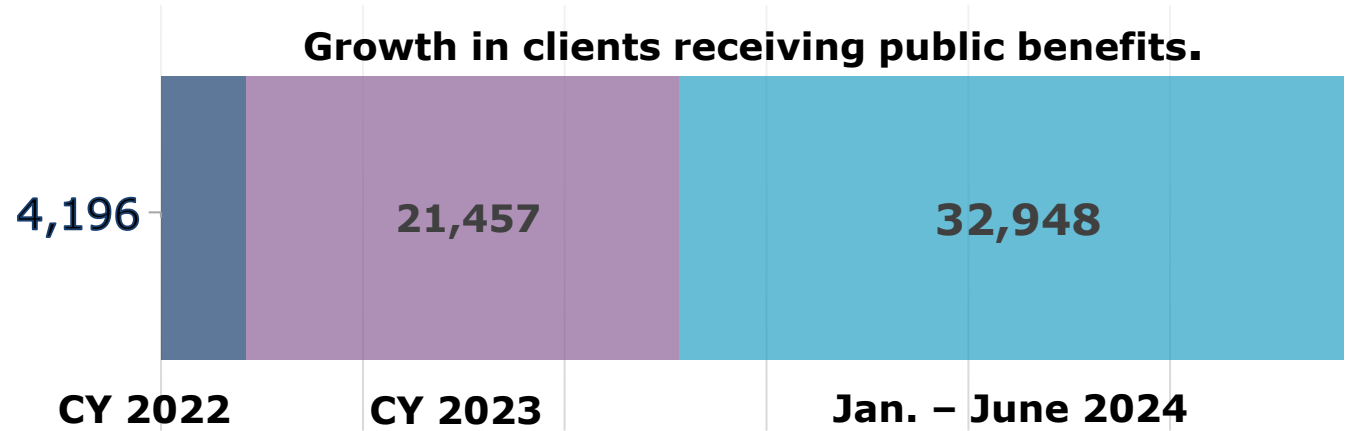
Asylum-seeker: is a person who has left their country and is seeking protection from persecution, but who has not yet been recognized as a refugee.

Migrant: is a person who leaves their country of origin to seek permanent or temporary residence in another country.

***The WA Migrant & Asylum-seeker Support Project is intended to serve migrants and asylum-seekers who are ineligible for federal refugee resettlement services.**

Washington's Response

Substitute House Bill 2368: Assisting refugees and immigrants:

- Coordinate statewide efforts to support the economic and social integration and basic needs of immigrants and refugees arriving and resettling in Washington. Allows services to immigrants who are ineligible for federal refugee resettlement services

Appropriation of \$25,250,000 of State-Funding for SFY 2024 and 2025

- \$22,740,000 to provide support services through the WA MASS Project.
- \$250,000 in FY 2024 and \$750,000 in FY 2025 provided solely for school districts.
- \$700,000 Provided solely for members of the Sub-Saharan African community.
- \$810,000 for ORIA Staff and Administrative Costs

Project Overview

Purpose: Build a statewide network of organizations to deliver a coordinated response to meet the short-term immediate needs of recently arrived migrants and asylum-seekers.

Participant Eligibility and Prioritization

Eligibility Criteria:

- Be a non-citizen residing in WA that entered the U.S. for the first time after Jan. 1, 2022, **and**
- Do not qualify for federal refugee resettlement services and benefits.

Prioritization Criteria:

- Lack federal Employment Authorization Document.
- Have been placed in removal proceedings because they were apprehended in the U.S. or at a port of entry without proper documentation.
- Have been unsheltered, staying in a building illegally, or staying in emergency shelter .
- Are a pregnant person or a member of a family with children under the age of 18.
- Persons with complex medical conditions
- An unaccompanied youth between the ages of 18 and 24
- Single women or single adults over the age of 65 years
