DSHS amends the RFQQ # 2435-857 to include questions and answers from the Pre-Bid Conference held on August 20, 2024 as well as the presentation from the same Pre-Bid Conference.

#### Bidder's Questions and Answers RFQQ# 2435-857

**Question #1:** Will the presentation be available for download afterwards and may I have the solicitation coordinator email address for additional questions?

**A:** The presentation will be posted as an amendment on WEBS and on the DSHS Procurement site along with the official answers from todays questions. Any additional questions should be sent to the solicitation coordinator at James.obrien2@dshs.wa.gov.

**Question #2:** Will there be a direct link available for the required documents?

**A:** They are posted on the DSHS website - as well as the WEBS site.

**Question #3:** What qualities and abilities would the ideal candidate possess?

**A:** We are looking for a bid that answers all the questions and qualifications as described in the RFQQ documents.

**Question #4:** Does it matter if I have more of a transportation background or a culinary background?

**A:** Food preparation and delivery services are both needed, and they are both equally important.

**Question #5:** Are food deliveries expected to be on individual trays or bulk delivery? How is delivery anticipated?

**A:** Please see Attachment A – Sample Contract for specifics. These requirements are described in detail in the sample contract.

**Question #6:** 3 meals, 3 snacks and beverages for each meal are expected. Does delivery include all meals, snack and beverages at once or multiple deliveries throughout the day?

**A:** The current vendor is delivering for the following day, and it includes 3 meals, 3 snacks and beverages for each meal. DSHS is open to alternatives if proposed.

Question #7: Is this the first launch or is there a current vendor?

**A:** The current vendor is Pioneer Human Services. This is not the first request for these services.

**Question #8:** Who is the current vendor?

**A:** Pioneer Human Services is the current vendor for both Maple Lane Campus and Olympic Heritage. They cannot continue to provide the service to Olympic Heritage as of September 1. New units will be coming on-line at Maple Lane Campus, expanding the client population. They cannot expand services to accommodate any added clients at Maple Lane Campus.

Question #9: What is the current contract going for?

**A:** The current contract(s) in place, do not reflect all the needs for this RFQQ. Below are some of the rates contained in the current contract(s). DSHS is looking for potential bidders to conduct their due diligence and offer DSHS the best pricing possible for the best quality of food possible. This decision of pricing is at the sole discretion of the bidder.

# Opening Remarks Behavioral Health Administration

The Department of Social and Health Services, Behavioral Health Administration transforms lives by supporting sustainable recovery, independence and wellness.

BHA Facilities provide in-patient behavioral health treatment in a secure environment to assist people in stabilizing their acute psychiatric symptoms and support the development and implementation of an individual recovery plan. Following treatment, it is the goal of the programs to transition patients back to the jail, the community, or to a less-restrictive setting.

## Background

BHA Facilities in need of this service may include but is not limited to the following:

#### **Short-term Needs:**

- Behavioral Health & Treatment Facility – Maple Lane Campus, located at 20311 Old Highway 9 Southwest, Centralia, Washington, 98531. Current client population is 76, but client population is expected to expand to 140 by February 2025.
- Olympic Heritage Behavioral Health Facility, located at 12844 Military Rd South, Tukwila, WA 98168. Current client population is 120.

#### Long-term Needs:

 Behavioral Health & Treatment Facility – Brockmann Campus, planned location at 16015 NE 50th Avenue, Vancouver, WA, 98686. This facility is currently under construction and planned client population is 48. Planned facility will open in phases and is scheduled to start in May 2025 and be completed by September 1, 2025 (total client population when complete will be 48).



#### Meal Delivery Site Map




