- b. Minutes from the 12/16/24 PSRP meeting were approved.
- c. Dr. Lopez discussed contracted providers at the various facilities and the scope of their contracts.
- d. Privilege implementation: Dr. Zinda discussed the ongoing processes of gathering information on the implementation (quality and quantity) of various privilege levels at each facility. This information will be reviewed with Assistant Secretary Kevin Bovenkamp.
- e. Therapeutic approaches to staff escorted community outings (SECO) at Maple Lane for NGRI patients. Dr. Nygard discussed how staff escorted community outings are implemented at Maple Lane. Used as an opportunity to be in less predictable outings and letting patients experience possible triggers with staff on site in managing with treatment team. Utilizes skill of managing a budget on SECO visits, and accountability. Where recommended, patients utilize SECO for off-site SUD treatment. Question asked as to how privileges are tracked when patients move from facility to facility, and if the specific court order is for a specific facility only/ Dr. Zinda reports that is currently being discussed and she will follow-up with the Panel on that.
