

## State-Operated Community Residential

State-Operated Community Residential is a division of the DSHS Developmental Disabilities Administration, consisting of four program models serving youth and adults with intellectual and developmental disabilities across Washington state. SOCR empowers program participants to achieve their personal goals, express individual choice and live their best life.

#### **Adult SOLA**

The Adult State-Operated Living Alternatives Program, or Adult SOLA, serves adults aged 18 years and over in seven counties across the state. Clients receive up to 24-hour individualized support in their own homes with up to three housemates, sharing rent, utilities and other household expenses. Trained staff provide highly personalized habilitation, skill development, medication management, community integration, advocacy and behavior intervention support. Clients also have access to employment or community inclusion services delivered through county contracts.



The Children's State-Operated Living Alternatives Program for Children serves youth aged 8 to 18 in the Spokane and Pierce County areas. Youth can stay in Children's SOLA until age 21 if they are enrolled in a transitional education program or vocational program. Up to three youth share a home in the community in which they receive 24-hour support based on their individual needs. Services provided include habilitation, behavior intervention, skill development, medication management, community integration, and advocacy. Children's SOLA homes provide a structured environment in which youth are empowered to pursue their individual goals while exercising good decision making and preparing for adulthood.

#### **Intensive Habilitation Services**

The Children's State-Operated Intensive Habilitation Services Program provides short-term stabilization services for a maximum of 90 days to eligible youth between age 8 to 17, or between

18 and 21 if enrolled in an educational transition program. Services are based on the



youth's habilitative goals as identified by their family in conjunction with the DDA case manager and IHS staff. Services are provided in an integrated setting which supports the youth's personal power, choice, and access to the greater community. IHS staff receive extensive training in positive behavior support principles and de-escalation techniques with a focus on teaching and training. This community-based facility is leased by DSHS, located in Pierce County, and provides 24-hour support for up to three youth at a time.

# Stabilization, Assessment, and Intervention Facility

The adult Stabilization, Assessment, and Intervention Facility is a DSHS leased facility located in Pierce County. SAIF provides shortterm stabilization and habilitative services for a maximum of 90 days for eligible adults. Supports focus on reducing clients' target behaviors as identified by their individualized treatment team. SAIF staff work with the clients to reduce the severity, frequency, and duration of the identified target behaviors using approved behavior supports and de-escalation techniques. This community-based facility is leased by DSHS, located in Pierce County, and provides 24-hour support for up to 6 adults at a time.

### State-Operated Community Residential Transitions Program

SOCR Transitions habilitation, stabilization and transition supports to adults found not competent to stand trial and not likely restorable due to a diagnosis of intellectual or developmental disability. The program supports clients in a structured home setting, for up to 180 days. SOCR Transitions staff work with the clients to develop skills and access resources to thrive, be safe and live independently while they seek long-term residential services or an alternate residential setting that meets their needs. This communitybased facility is leased by DSHS, located in Yakima County, and provides 24-hour support for up to 3 adults at a time per site.
